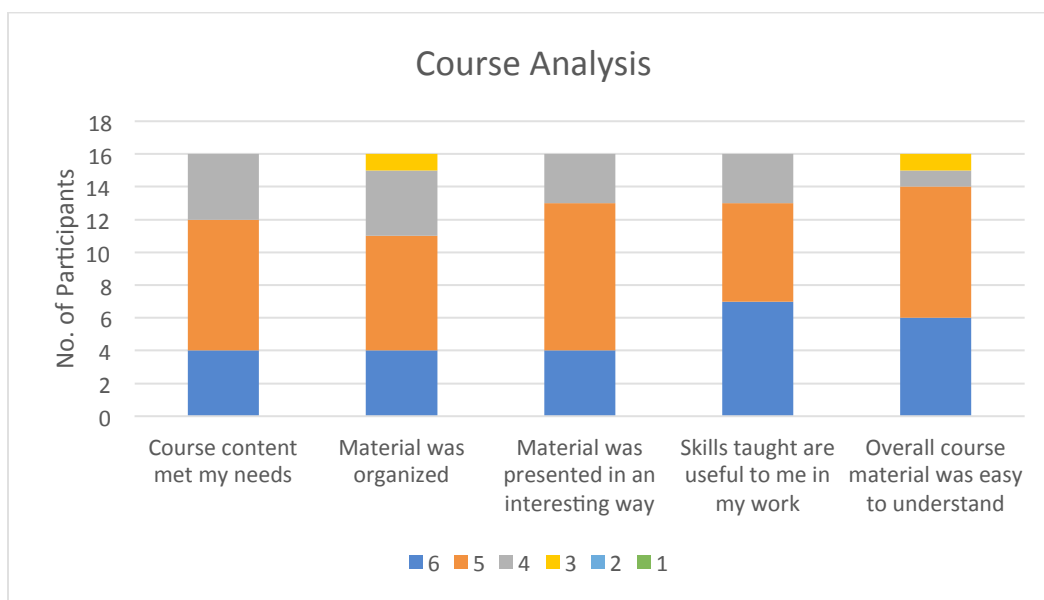

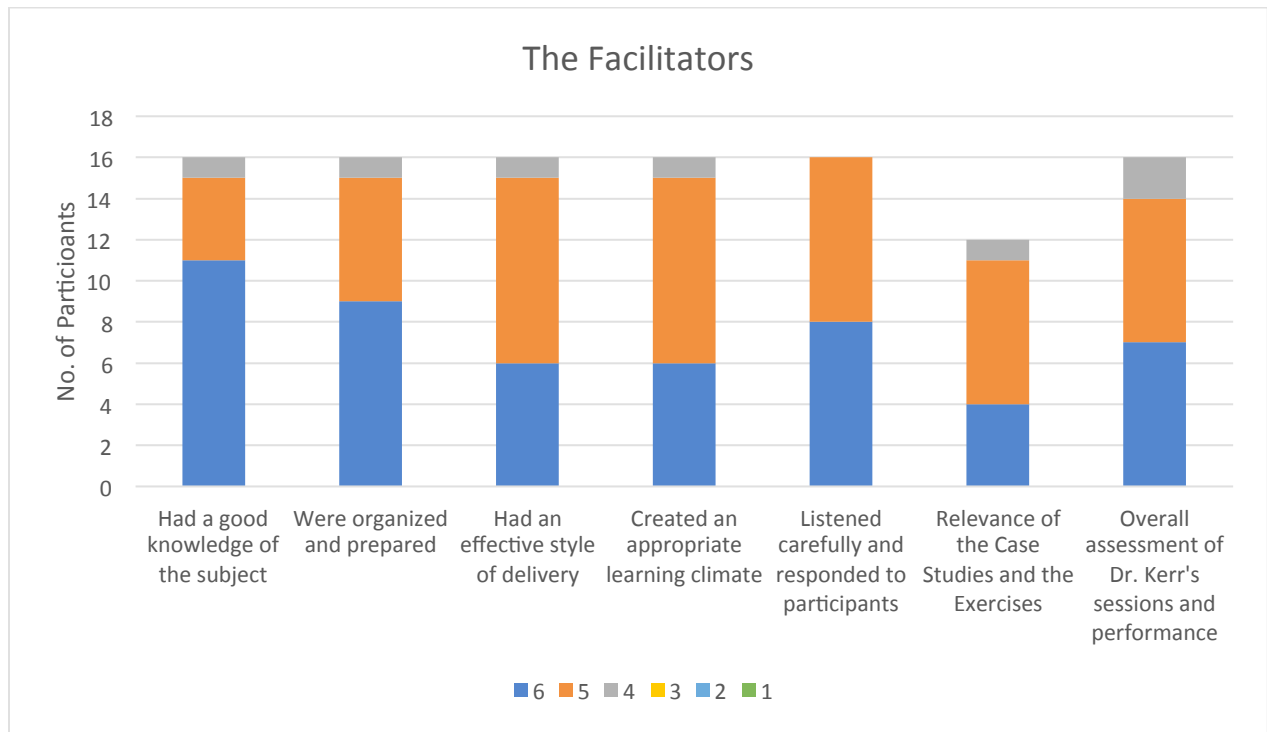
#### Section 1: Course

## Section 2: The Facilitators



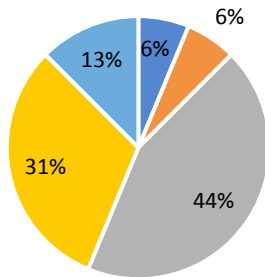
The above bar graph represents the responses from 16 participants on questions concerning the Facilitator of the **PAD & One Day Masterclass Workshop**.

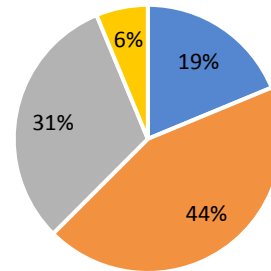
Knowledge Before the Workshop

Knowledge After the Workshop

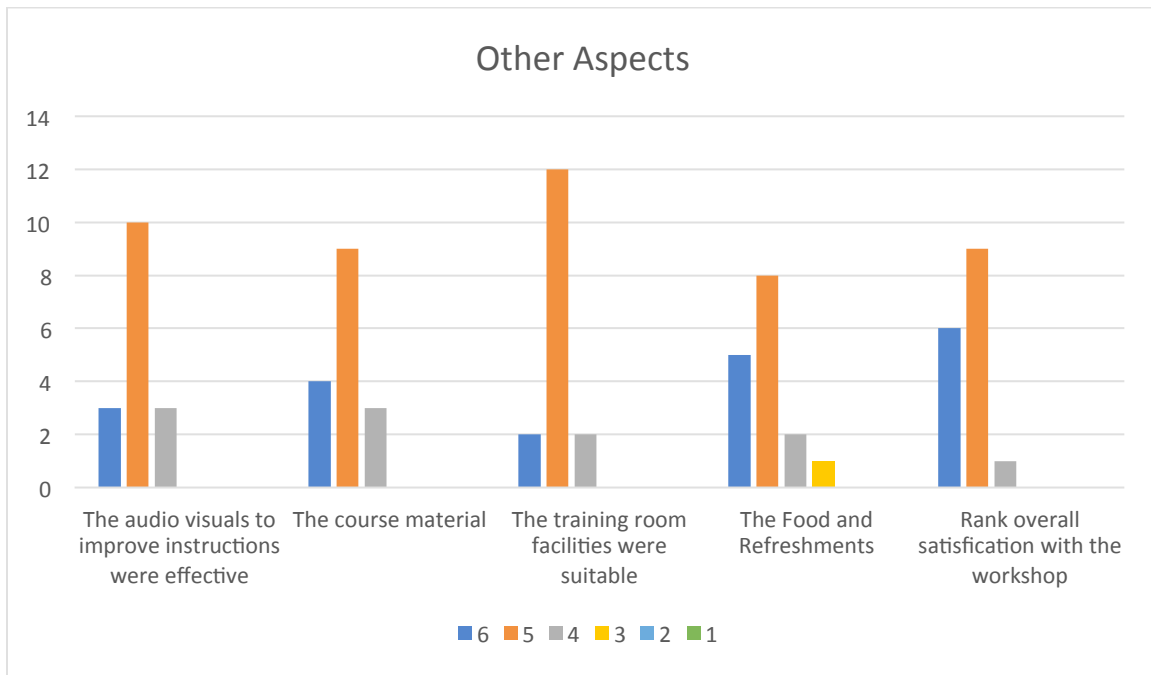

The above pie charts represent the responses from 16 participants on questions concerning the level of knowledge of each person before and after attending the workshop.

- An overall mixed level of results was reported for the rate of knowledge before the workshop, with all participants recording a rate of knowledge between 2-6.
- The majority of participants reported a rate of either 4 or 3 for their knowledge before the workshop.
- The majority response for rate of knowledge after the workshop was a level of 5, with the second highest response being a level of 4.
- This indicated that most persons saw an increase in their knowledge after completing the course.

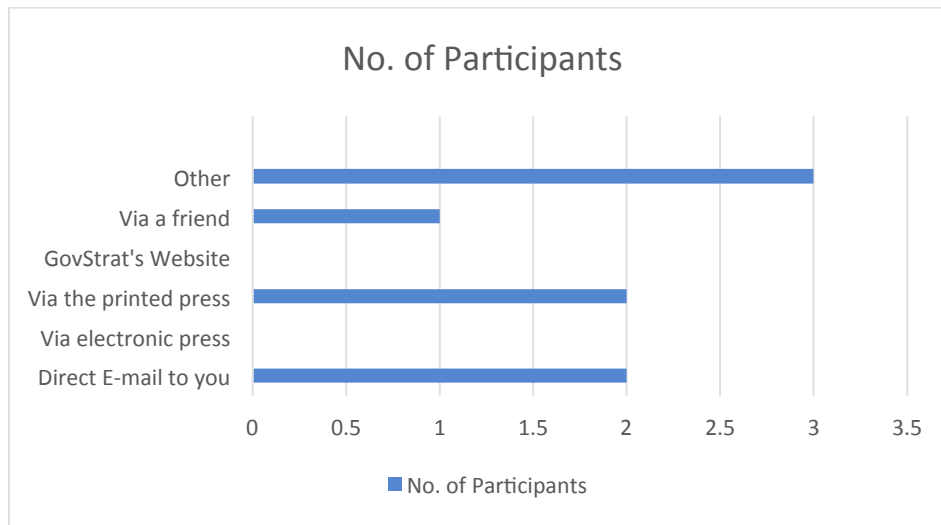
## Section 5: Open Ended Questions
